### Keynote – Records Management 2.0: Compliance and the Cloud:

Outsourcing non-core functions has been a part of organizational strategy for years. Now many organizations are considering outsourcing of their data storage, their email, and even their employees' desktops to "the cloud". But how do you manage the records out there? In this session attendees will learn what Web 2.0 is and what it means to individuals, organizations, and their relationships to each other. We will briefly examine some of the more common tools being employed, including Web 2.0-based email, office productivity, project management, and desktop solutions. We will describe how to identify records stored with these tools and what that means to the records program. The session will conclude with strategies for managing Web 2.0 tools and records.

### Workshop - Records Management 2.0: Compliance and the Cloud:

ARMA has a blog. Wikipedia includes more than 3,000,000 articles, and every broadcaster now asks you to follow them on Twitter. Are these more than just the latest buzzwords? In this session, we will define Web 2.0 tools including blogs, wikis, twitter, social networking, cloud computing, and others. We will outline ways organizations are already using these tools to communicate, collaborate, and conduct business and what that means to the records program. The session will conclude with strategies for managing Web 2.0 applications effectively from both process and technology perspectives.

### Motivational Session – Generational Gap Communications:

As if dealing with everyone in cyber space wasn't tricky enough, what about dealing with them face-to-face? As you know, we've got more generations than ever in the workplace and it's getting harder to communicate and to understand each other. In her high-energy, often hilarious session, Denise Ryan will address issues such as managing different generations, improving inter-generational communication, and dealing with stereotypes. It will help participants understand not only co-workers but also clients and family members. Understanding others is challenging enough, but the generational differences throw in a whole new twist. This session will help you be more effective.
